1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to

increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

3. Generic

Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for 3 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.

4. Generic

Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

5. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

6. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

7. Turnover

OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. In case of bunch bids, the OEM of CATEGORY RELATED TO primary product having highest bid value should meet this criterion.

8. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

9. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

10. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

11. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

12. Certificates

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

13. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Bidder PAN Number is Compulsory and GST return file should be completed by March 2024
- 2. Bidder should produce shop act license/Factory registration certificate/MSME/firm registration.
- 3. Technical Specification with photo of Item must attach. Declaration for the same should be submitted by the Bidder on letterhead.
- 4. Self-declaration stating about non-inclusion in Blacklist the firm company by any government organizati ons and not supplying refurbished equipment's. Bids are not allowed from manufacturer for the item (s) for which the firm found guilty of malpractice, misconduct, or blacklisted/debarred either by any Department, Govt. of Maharashtra or by any local authority, Other State
- 5. Terms & Condition Acceptance Certificate should be submitted on letterhead.
- 6. Any type of transport fare, loading unloading charges and zakat will not be paid by this office
- 7. The supply of the said material is to be done within 15 working days from the receipt of the order. If the work is not completed within the prescribed time, there will be a penalty of 0.5% per week and a maximum of 10% of the tender amount. The final authority regarding extension without penalty in exceptional circu mstances rests with Hon'ble chief executive officer.
- 8. Government deductions (taxes, fines if any) required as per rules while making the payment amount of f ine etc. will be done...
- 9. An amount of 3% of the supply order amount will be retained from the payment in the form of secured d eposit for 1 years.
- 10. In case of judicial dispute, its jurisdiction shall be Sangli district. Similarly, if changes are made as Per i nstructions and government decisions issued from time to time, action will betaken accordingly.
- 11. The undersigned reserves the right to Chief Executive Officer, Zilla parishad, sangli at any level to canc el the supply order in case of non compliance with the above terms and conditions.
- 12. As soon as the supply order received, the contract is to be signed on stamp paper.
- 13. After receipt of the said material, it is mandatory to submit quality inspection certificate of goods on pa yment as per specification from any recognized body mentioned by consignee departments. Energy and L abour Department dated 1" December, 2016 G.R. If any the said material is found to be defective, Hon,ble CEO shall have full right to reject the material.
- 14. Bidder financial standing: The bidder shoud not be under liquidation court receivership or similar with b id. Proceedings should not be bankrupt. Bidder to upload undertaking of this office.
- 15. Submissionm of consignee Receipt and Acceptance Certificate (CRAC) is mandatory for experience Crit
- 16. Department of Industres, Energy and Labour Department G.R dated 1" December 2016, accordingly all terms and conditions related to procurements shall be mandatory for the supplier.
- 17. As per the RDD gov. Letter dated 18th May2023, it is stated that preference should be given to local S upplier.

- 18. Submitting a self-declaration that all submitted documents in Bid are verified and found correct.
